As of May 8th, Sumter County has 226 cases of Covid-19 with 14 deaths. 70 are in The Villages, 101 are in Bushnell (89 inmates and 9 staff in the county correction facility) 22 are in Panasoffkee. Wildwood has creeped up to 9. All 14 deaths were mid-70's and older with health problems.

We are giving fair warning to stop this pass thru Tax for the following reasons.

We will be sending this same letter in the fall September or October 2020 to comply with the 90 day mandate time.

#### Dear Officer:

James and Brad have been asked to construct the letter for the Parkwood Limited HOA.

We would like four (4) questions answered.

- 1) The name of the governmental entity MANDATING the Capital Improvement. 723.003 (10)
- 2) The nature and type of the pass thru being Levied. section 723.003 (10)
- 3) The starting and ending dates of each pass thru charge (section (723.037)
- 4) Pass thru levied are for ONE year. (section 723.031 (5) (c)
- 5) In the past 4 years of being taxed we have received but one letter to answer our questions, the only letter we received is included with two dated on the sheet 209 and 2020 and no answers of satisfaction.

\$90 – \$100 fee, we as residents of Parkwood Limited have been billed by management for the last few years.
